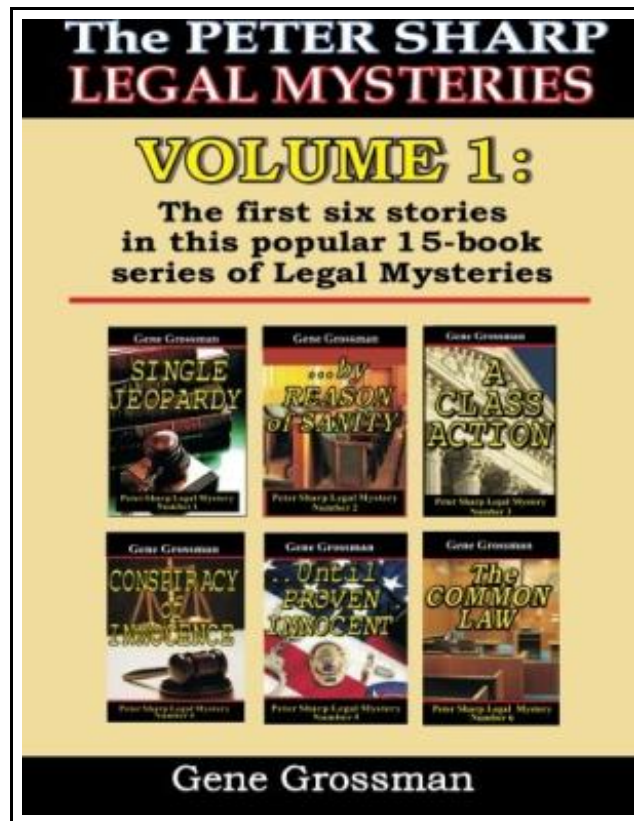

By way of background for this series, in 2003 Gene Grossman retired from the practice of law, and drew upon his 20 years as a trial attorney to create the first Peter Sharp Legal Mystery - and during the next decades he succeeded in writing fifteen books in the series, and went on to spin-off the most interesting character into a brand new series - the Suzi B. Mysteries. Now, Gene is breaking new ground again by offering readers the complete text of the first six books in the Peter Sharp series, so that avid readers can have them all in one volume, and save money at the same time. The same cast of characters appear every book of the series, but each one stands on its own and is a completely new story with no references to any of the previous one, so that you can start reading anyone of them at any time, without feeling that you ve missed. With this set of the first six, you ll have an opportunity to read the first one first. It gives a little more of the back story about how Peter and Suzi started their law practice.
